- 2 **SEC. 7. REPORT ON PROVISION OF SERVICES TO MEMBERS**
- 3 **OR AFFILIATES OF HAMAS; IMPOSITION OF**
- 4 **SANCTIONS.**
- 5 (a) IDENTIFICATION OF MEMBERS OR AFFILIATES
- 6 OF HAMAS.—Not later than 15 days after the date of the
- 7 enactment of this Act, the Secretary of State, in consulta-
- 8 tion with the Secretary of the Treasury, shall submit to
- 9 Congress a report listing all foreign persons currently

1 known to the United States to be a member or affiliate
2 of Hamas.

3 (b) SANCTIONS.—

4 (1) IN GENERAL.—The President shall impose
5 the sanctions described in paragraph (2) with re-
6 spect to each foreign person on the list required by
7 subsection (a).

8 (2) SANCTIONS DESCRIBED.—The sanctions de-
9 scribed in this paragraph are—

10 (A) the sanctions applicable under Execu-
11 tive Order 13224 (50 U.S.C. 1701 note; relat-
12 ing to blocking property and prohibiting trans-
13 actions with persons who commit, threaten to
14 commit, or support terrorism); and

15 (B) inclusion on the list of specially des-
16 ignated nationals and blocked persons main-
17 tained by the Office of Foreign Assets Control
18 of the Department of the Treasury.

19 (c) DEFINITIONS.—In this section:

20 (1) FOREIGN PERSON.—The term “foreign per-
21 son” means an individual or entity that is not a
22 United States person.

23 (2) MEMBER OR AFFILIATE OF HAMAS.—The
24 term “member or affiliate of Hamas” includes—

- 1 (A) an official, agent, member, or affiliate
2 of Hamas;
- 3 (B) an official, agent, member, or affiliate
4 of—
- 5 (i) the Palestine Islamic Jihad;
6 (ii) the Popular Resistance Commit-
7 tees;
8 (iii) the Abd Al-Qadir Al-Husseini
9 Brigades;
10 (iv) the Democratic Front for the Lib-
11 eration of Palestine;
12 (v) the Lion's Den;
13 (vi) Liwa al-Quds;
14 (vii) Liwa Fatemiyoun;
15 (viii) Liwa Zeynabiyoun; or
16 (ix) the Palestinian Mujahideen Move-
17 ment;
- 18 (C) any successor to a person described in
19 subparagraph (A) or (B); or
- 20 (D) any foreign person owned or controlled
21 by a person described in subparagraph (A) or
22 (B).
- 23 (3) UNITED STATES PERSON.—The term
24 “United States person” means—

1 (A) a United States citizen or an alien law-
2 fully admitted for the permanent residence to
3 the United States; or

4 (B) an entity organized under the laws of
5 the United States or of any jurisdiction within
6 the United States, including a foreign branch of
7 such an entity.
