1 At the end of title VII, add the following:

2 SEC. 716. TERMINATION OF CERTAIN WAIVERS OF SANC-3 TIONS WITH RESPECT TO NUCLEAR ACTIVI-4 TIES IN OR WITH IRAN.

5 (a) IN GENERAL.—Effective on the date of the enactment of this Act, any waiver of the application of sanctions 6 7 provided for under sections 1244, 1245, 1246, and 1247 8 of the Iran Freedom and Counter-Proliferation Act of 9 2012 (22 U.S.C. 8803, 8804, 8805, and 8806) for or to 10 enable an activity described in subsection (b) is termiROS22A72 7LY

 for such an activity on or after such date of enactment.
 (b) ACTIVITIES DESCRIBED.—An activity described
 in this subsection is an activity in or with Iran with re spect to which a waiver described in subsection (a) was
 issued in connection with the Joint Comprehensive Plan
 of Action, including the following:

8 (1) Modernization or redesign of the Arak reac-9 tor.

10 (2) Preparation or modification of centrifuge
11 cascades at the Fordow facility for stable isotope
12 production.

13 (3) Operations, training, or services related to
14 the Bushehr Nuclear Power Plant, including fuel de15 livery and take-back.

16 (4) Transfer of uranium into or outside Iran,
17 including natural uranium, enriched uranium, or nu18 clear fuel scrap.

19 (5) Transfer or storage of Iranian heavy water,20 inside or outside of Iran.

(c) JOINT COMPREHENSIVE PLAN OF ACTION DEFINED.—In this section, the term "Joint Comprehensive
Plan of Action" means the Joint Comprehensive Plan of
Action signed at Vienna on July 14, 2015, by Iran and
