3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Global Magnitsky5 Human Rights Accountability Reauthorization Act".

6 SEC. 2. MODIFICATIONS TO AND REAUTHORIZATION OF

7 SANCTIONS WITH RESPECT TO HUMAN8 RIGHTS VIOLATIONS.

9 (a) DEFINITIONS.—Section 1262 of the Global 10 Magnitsky Human Rights Accountability Act (Subtitle F 11 of title XII of Public Law 114–328; 22 U.S.C. 2656 note) $\mathbf{2}$

is amended by striking paragraph (2) and inserting the
 following:

3 "(2) IMMEDIATE FAMILY MEMBER.—The term
4 "immediate family member', with respect to a foreign
5 person, means the spouse, parent, sibling, or adult
6 child of the person.".

7 (b) SENSE OF CONGRESS.—The Global Magnitsky
8 Human Rights Accountability Act (Subtitle F of title XII
9 of Public Law 114–328; 22 U.S.C. 2656 note) is amended
10 by inserting after section 1262 the following new section:
11 "SEC. 1262A. SENSE OF CONGRESS.

12 "It is the sense of Congress that the President should 13 establish and regularize information sharing and sanc-14 tions-related decision making with like-minded govern-15 ments possessing human rights and anti-corruption sanc-16 tions programs similar in nature to those authorized under 17 this subtitle.".

18 (c) IMPOSITION OF SANCTIONS.—

19 (1) IN GENERAL.—Subsection (a) of section
20 1263 of the Global Magnitsky Human Rights Ac21 countability Act (Subtitle F of title XII of Public
22 Law 114–328; 22 U.S.C. 2656 note) is amended to
23 read as follows:

24 "(a) IN GENERAL.—The President may impose the
25 sanctions described in subsection (b) with respect to—

1	"(1) any foreign person that the President de-
2	termines, based on credible information—
3	"(A) is responsible for or complicit in, or
4	has directly or indirectly engaged in, serious
5	human rights abuse;
6	"(B) is a current or former government of-
7	ficial, or a person acting for or on behalf of
8	such an official, who is responsible for or
9	complicit in, or has directly or indirectly en-
10	gaged in—
11	"(i) corruption, including—
12	"(I) the misappropriation of state
13	assets;
14	"(II) the expropriation of private
15	assets for personal gain;
16	"(III) corruption related to gov-
17	ernment contracts or the extraction of
18	natural resources; or
19	"(IV) bribery; or
20	"(ii) the transfer or facilitation of the
21	transfer of the proceeds of corruption;
22	"(C) is or has been a leader or official of—
23	"(i) an entity, including a government
24	entity, that has engaged in, or whose mem-
25	bers have engaged in, any of the activities

1	described in subparagraph (A) or (B) re-
2	lated to the tenure of the leader or official;
3	or
4	"(ii) an entity whose property and in-
5	terests in property are blocked pursuant to
6	this section as a result of activities related
7	to the tenure of the leader or official;
8	"(D) has materially assisted, sponsored, or
9	provided financial, material, or technological
10	support for, or goods or services to or in sup-
11	port of—
12	"(i) an activity described in subpara-
13	graph (A) or (B) that is conducted by a
14	foreign person;
15	"(ii) a person whose property and in-
16	terests in property are blocked pursuant to
17	this section; or
18	"(iii) an entity, including a govern-
19	ment entity, that has engaged in, or whose
20	members have engaged in, an activity de-
21	scribed in subparagraph (A) or (B) con-
22	ducted by a foreign person; or
23	"(E) is owned or controlled by, or has
24	acted or been purported to act for or on behalf
25	of, directly or indirectly, a person whose prop-

1	erty and interests in property are blocked pur-
2	suant to this section; and
3	"(2) any immediate family member of a person
4	described in paragraph (1).".
5	(2) Consideration of certain informa-
6	TION.—Subsection (c)(2) of such section is amended
7	by inserting "corruption and" after "monitor".
8	(3) Requests by congress.—Subsection (d)
9	of such section is amended—
10	(A) in paragraph (1)—
11	(i) in the matter preceding subpara-
12	graph (A), by striking "subsection (a)"
13	and inserting "subsection $(a)(1)$ "; and
14	(ii) in subparagraph (B)(i), by insert-
15	ing "or an immediate family member of
16	the person"; and
17	(B) in paragraph (2)—
18	(i) in subparagraph (A)—
19	(I) in the subparagraph heading,
20	by striking "HUMAN RIGHTS VIOLA-
21	TIONS' and inserting "SERIOUS
22	HUMAN RIGHTS ABUSE''; and
23	(II) by striking "described in
24	paragraph (1) or (2) of subsection
25	(a)" and inserting "described in sub-

1	section $(a)(1)$ relating to serious
2	human rights abuse''; and
3	(ii) in subparagraph (B)—
4	(I) in the matter preceding clause
5	(i), by striking "described in para-
6	graph (3) or (4) of subsection (a)"
7	and inserting "described in subsection
8	(a)(1) relating to corruption or the
9	transfer or facilitation of the transfer
10	of the proceeds of corruption"; and
11	(II) by striking "ranking member
12	of" and all that follows through the
13	period at the end and inserting "rank-
14	ing member of one of the appropriate
15	congressional committees".
16	(4) TERMINATION OF SANCTIONS.—Subsection
17	(g) of such section is amended, in the matter pre-
18	ceding paragraph (1), by inserting "and the imme-
19	diate family members of that person" after "a per-
20	son''.
21	(d) Reports to Congress.—Section 1264(a) of the
22	Global Magnitsky Human Rights Accountability Act (Sub-
23	title F of title XII of Public Law 114–328; 22 U.S.C.
24	2656 note) is amended—

1	(1) in paragraph (5), by striking "; and" and
2	inserting a semicolon;
3	(2) in paragraph (6), by striking the period at
4	the end and inserting "; and"; and
5	(3) by adding at the end the following:
6	"(7) A description of additional steps taken by
7	the President through diplomacy, international en-
8	gagement, and assistance to foreign or security sec-
9	tors to address persistent underlying causes of seri-
10	ous human rights abuse and corruption in each
11	country in which foreign persons with respect to
12	which sanctions have been imposed under section
13	1263 are located.".
14	(e) REPEAL OF SUNSET.—Section 1265 of the Global
15	Magnitsky Human Rights Accountability Act (Subtitle F
16	of title XII of Public Law 114–328; 22 U.S.C. 2656 note)
17	is repealed.
