AMENDMENT IN THE NATURE OF A SUBSTITUTE intended  
to be proposed by Mr. RISCH

Viz:

- 1 Strike all after the resolving clause and insert the fol-
- 2 lowing: "That the Senate—
- 3 (1) reiterates its strongest condemnation of the
- 4 1992 attack on the Israeli Embassy in Argentina
- 5 and the 1994 attack on the Argentine Israelite Mu-
- 6 tual Association (AMIA) Jewish Community Center
- 7 in Buenos Aires;
- 8 (2) honors the victims of the 1992 bombing of
- 9 the Israeli Embassy in Argentina and the 1994
- 10 AMIA bombing, and expresses its sympathy to the

1 relatives of the victims, who are still waiting for jus-  
2 tice;

3 (3) underscores the concern of the United  
4 States regarding the continuing, decades-long delay  
5 in resolving the 1992 and 1994 terrorist attacks in  
6 Argentina, and urges the President of the United  
7 States to offer technical assistance to the Govern-  
8 ment of Argentina to support the ongoing investiga-  
9 tions;

10 (4) urges the Government of Argentina and the  
11 international community to continue efforts to bring  
12 the perpetrators of the March 17, 1992, and July  
13 18, 1994, terrorist attacks to justice, including en-  
14 forcing the INTERPOL Red Notices and extending  
15 them when they are up for review in November  
16 2022;

17 (5) calls upon the Government of Argentina to  
18 conclude the investigation into the murder of Alberto  
19 Nisman such that those responsible are brought to  
20 justice;

21 (6) commends the Government of Argentina for  
22 designating Hezbollah as a terrorist organization  
23 and urges other United States allies and partners in  
24 Latin America and the Caribbean to do the same;

1           (7) commends the Government of Argentina for  
2           adopting the International Holocaust Remembrance  
3           Alliance working definition of antisemitism and en-  
4           courages other partners and allies to do the same.
