1 and importance of ties between the United States 2 and Japan; 3 (3) in 2015, which marks 70 years since the 4 end of World War II, the United States and Japan 5 continue to strengthen the alliance and work to-6 gether to ensure a peaceful and prosperous future 7 for the Asia-Pacific region and the world; 8 (4) the Governments and people of the United 9 States and Japan share values, interests, and capa-10 bilities that have helped to build a strong rules-based 11 international order, based on a commitment to rules, 12 norms and institutions; 13 (5) the revised Guidelines for United States-14 Japan Defense Cooperation and Japan's policy of 15 "Proactive Contribution to Peace" will reinforce de-16 terrence, update the roles and missions of the 17 United States and Japan, enable Japan to expand 18 its contributions to regional and global security, and 19 allow the United States Government and the Gov-20 ernment of Japan to enhance cooperation on secu-21 rity issues in the region and beyond; 22 (6) the United States remain resolute in its 23 commitments under the Treaty of Mutual Coopera-24 tion and Security to respond to any armed attack in 25 the territories under the administration of Japan;
