4 It is the sense of Congress that—

5 (1) the alliance between the United States and
6 the Republic of Korea has served as an anchor for
7 stability, security, and prosperity on the Korean Pe8 ninsula, in the Asia-Pacific region, and around the
9 world;

10 (2) the United States and the Republic of
11 Korea continue to strengthen and adapt the bilat12 eral, regional, and global scope of the comprehensive

1 strategic alliance between the two nations, to serve 2 as a linchpin of peace and stability in the Asia-Pa-3 cific region, recognizing the shared values of democ-4 racy, human rights, free and open marketS, and the 5 rule of law, as reaffirmed in the May 2013 "Joint 6 Declaration in Commemoration of the 60th Anniver-7 sary of the Alliance between the Republic of Korea 8 and the United States of America";

9 (3) the United States and the Republic of 10 Korea continue to broaden and deepen the alliance 11 by strengthening the combined defense posture on 12 the Korean Peninsula, enhancing mutual security 13 based on the Republic of Korea-United States Mu-14 tual Defense Treaty, and promoting cooperation for 15 regional and global security in the 21st century;

(4) the United States and the Republic of 16 17 Korea share deep concerns that the nuclear, cyber, 18 and ballistic missiles programs of North Korea and 19 its repeated provocations pose grave threats to peace 20 and stability on the Korean Peninsula and North-21 east Asia and recognize that both nations are deter-22 mined to achieve the peaceful denuclearization of 23 North Korea and remain fully committed to con-24 tinuing close cooperation on the full range of issues 25 related to North Korea;

(5) the United States and the Republic of 1 2 Korea are particularly concerned that the nuclear 3 and ballistic missile programs of North Korea, in-4 cluding North Korean efforts to miniaturize their 5 nuclear technology and improve the mobility of their 6 ballistic missiles, have gathered significant momen-7 tum and are poised to expand in the coming years; 8 (6) the Republic of Korea has made progress in 9 enhancing future warfighting and interoperability 10 capabilities by taking steps toward procuring Patriot 11 Advanced Capability missiles, F-35 Joint Strike 12 Fighter Aircraft, and RQ-4 Global Hawk Surveil-13 lance Aircraft; 14 (7) the United States supports the vision of a 15 Korean Peninsula free of nuclear weapons, free from 16 the fear of war, and peacefully reunited on the basis 17 of democratic and free market principles, as articu-18 lated in President Park's address in Dresden, Ger-19 many; and 20 (8) the United States and the Republic of 21 Korea share the future interests of both nations in 22 securing peace and stability on the Korean Penin-23 sula and in Northeast Asia.
