3 (a) NEEDS ASSESSMENT.—Not later than 180 days
4 after the date of the enactment of this Act, the Secretary,
5 in consultation with the Secretary of Labor, shall submit
6 a needs assessment to the appropriate congressional com7 mittees that—

8 (1) identifies United States embassies that
9 would benefit from the presence of a labor attaché
10 from the Department of Labor;

1	(2) focuses on countries with the lowest labor
2	standards, as described in the Department's "Coun-
3	try Reports on Human Rights Practices", published
4	in the International Labour Organization' "Rules of
5	the Game", and compiled in the International Trade
6	Union Confederation's "Global Rights Index";
7	(3) focuses on countries that have entered into
8	labor rights commitments with the United States
9	through trade agreements or preference programs;

11	(4) determines, in consultation with the Depart-
12	ment of Labor, whether sufficient resources are allo-
13	cated for the monitoring and promotion of labor

15	(b) RESOURCES.—
16	(1) IN GENERAL.—The Secretary, in consulta-
17	tion with the Secretary of Labor, shall allocate ap-
18	propriate resources for labor rights promotion, in-
19	cluding the deployment of labor attachés to embas-
20	sies identified under subsection $(a)(1)$.
21	(2) LABOR ATTACHÉS.—Under the direction of
22	the Chief of Mission, the labor attachés deployed to
23	embassies pursuant to paragraph (1) shall promote
24	labor rights through engagement with host-govern-

3	(c) Special Representative for International
4	LABOR.—
5	(1) ESTABLISHMENT.—The Secretary shall es-
6	tablish a permanent position within the Bureau of
7	Democracy, Human Rights, and Labor, which shall
8	be referred to as the "Special Representative for
9	International Labor".
10	(2) DUTIES.—Under the direction of the Un-
11	dersecretary for Civilian Security, Democracy, and
12	Human Rights, the Special Representative for Inter-
13	national Labor shall oversee the Department's co-
14	ordination with the Department of Labor to assess
15	and ensure that sufficient resources are being dedi-
16	cated to labor rights within the embassies identified
17	under subsection $(a)(1)$.
